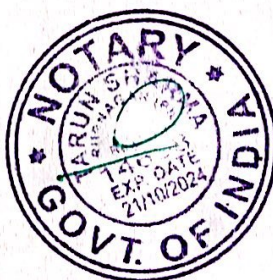
1. Finess certificate: - all the school buses have fitness certificate from RTO, Pollution and insurance.

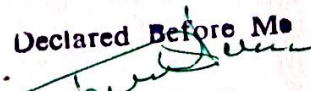
All the safety features and guidelines along with school contact number are displayed on the front and back of the school buses.
